His analysis focuses on the production of welfare, understood as the articulation of welfare programmes and institutions – including the state, markets and households – insuring households against social risks.

The article finds evidence to support both contentions: food insecurity has risen across many European countries and has varied by welfare regime. It also finds that contrary to expectations, the sharpest rise was in the Anglo-Saxon countries of Ireland and the UK, rather than Southern or Eastern European countries.

The common theme of the presentations, drawn from multiple disciplines, was that political structures such as welfare regimes influence the obesity epidemic.
